The General Law of Companies (Ley General de Sociedades) (LGS) does not set out a minimum stock capital requirement to incorporate a corporation. However, Peruvian banks sometimes do not accept capital deposits for new companies for less than approximately PEN3,300.00. The capital of a corporation is represented by registered shares of stock.

The Company law requires that financial statements be prepared in accordance with generally accepted accounting principles in Peru. Law No. 28708 of 1987 established the Accounting Standards Board (CNC)—which operates under the auspices of the National Direction of Public Accounting (DGCP) as part of the Ministry of Economy and Finance—as the organization responsible for setting accounting standards for all non-regulated companies.

In March 2013, the Supreme Decree N° 003-2013-JUS-Regulation of the PDLP (Regulation) was published in order to develop, clarify and expand on the requirements of the PDPL and set forth specific rules, terms and provisions regarding data protection. Peru is a party to the Convention on the International Regulations for Preventing Collisions at Sea (1972). In respect of national law, collision is regulated in Section IV, Chapter III of the Peruvian Code of Commerce and in the Law of Control and Surveillance of Maritime, River and Lake Activities.

In general, Peruvian regulations regarding corporations are similar to those found in other jurisdictions. The corporation is a capital stock company which capital is represented by shares and grants its shareholders the rights set forth in the General Corporations Law and in the respective company's by-laws. Social benefits for company employees (Income Tax Law Article 18(c)). If an association or foundation pursues purposes included in the respective articles but also others not incorporated in those articles, Peru's National Tax Administration (Superintendencia Nacional de Aduanas y de Administracion Tributaria, or SUNAT) will deny an application for exemption, for failure to meet the "exclusivity" requirement.

Peru's General Health Law provides the legal framework for sanitary supervision regulations and oversight of food and beverage products. The provisions are implemented through rules, decrees and supreme resolutions published in the official gazette (El Peruano). DIGESA is responsible for implementing Peru's food product regulations.
